C., and being shown as the greater portion of Lot No. 34 and the lesser portions of Lots Nos. 32 and 36 on the plat of Hillside Terrace, recorded in the RMC Office for Greenville County, S. C. in Plat Book F, page 154, and having according to a more recent survey made by R. W. Dalton, dated May, 1954, the following metes and bounds, to-wit:
