All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northern side of Colonial Avenue near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 12, Block V, as shown on a plat of Riverside recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book A at pages 322-323 and also on a duplicate plat of Riverside recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book K at pages 281-284, and having according to said plat, the following metes and bounds:
