NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwestern side of Knoll Circle, being shown and designated as Lot No. 26 on a Map of a Revision of GRANDVIEW HILLS made by R. B. Bruce, Surveyor, dated March 26, 1969, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book WWW, page 52, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwestern side of Knoll Circle at the common corners of Lots Nos. 26 and 27, and running thence along said side of Knoll Circle, N.49-51 E., 35 feet to an iron pin; thence with the curve of the Northwestern side of Knoll Circle, the following chord and courses and distances: N.18-20 E., 35.2 feet to an iron pin, and N.50-51 E., 50 feet to an iron pin at the joint front corners of Lots Nos. 25 and 26; thence along the common line of said lots, N.7-43 E., 247.6 feet to an iron pin; thence S.49-51 W., 275 feet to an iron pin at the joint rear corners of Lots Nos. 26 and 27; thence along the common line of said lots, S.40-15 E., 200 feet to an iron pin, the beginning corner.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's amount and collect it as part of the debt secured by the mortgage.

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgage may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company \* Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

\* insuring this loan, and the mortgagor agrees to pay to the mortgagee as premium for such insurance one half of 1% of the principal balance then existing.
