NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown as Lot 22 on plat of Fairway Acres, Part II, recorded in the RMC Office for Greenville County in Plat Book 4F, at page 43, and having the following metes and bounds, to-wit:

BEGINNING at a point on the north side of Terrain Drive, joint corner of Lots 21 and 22 and running thence N. 34-39 W. 186.3 feet; thence N. 62-08 E. 200 feet; thence S. 35-08 E. 165.1 feet to Terrain Drive; thence along said Drive S. 56-04 W. 200 feet to the beginning point.

This mortgage and the note which it sedures may not be assumed by any part or parties or subsequent purchasers of the property, and in the event this property is sold or transferred by contract, deed or otherwise this mortgage and the note which same secures hall become immediately due and payable in full.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lowfully seized of the premises horoinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagor forever, from and against the Mortgagor and all persons whomsoever tawfully claiming the same or any part thereof.
