We do hereby agree to pay all taxes and other public assessments against this the Citizens Building and Loan Association, Greer, S. C., immediately upon such payment, until all amounts due under this mortgage have been paid in full; and should

C., immediately upon such payment, until all amounts other governmental assessments, the Mortgagee may, at its option, pay same and charge same amounts to the mortgage debt, and collect the same under this mortgage, with interest thereon.
