All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the Southeastern corner of the intersection of Old Spartanburg Road (East North Street Extension) with the Butler Springs Road, being shown and designated as Lot No. 9 on a plat of Section II for SPRING FOREST, dated October 1964, made by C. O. Riddle; Surveyor, recorded in the RMC Office for Greenville County, South Carolina in Plat Book BBB, page 34, and having according to said plat, the following metes and bounds, to wit:
