NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, all that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 6 on plat of Flizabeth Heights recorded in the RMC office for Greenville County in plat book KK at page 11, said lot having a frontage of 75 feet on the southeast side of Statunton Bridge Rbad.

This is the same lot conveyed to grantor by AubreyC. Fore individually and as Executrix of the Estate of M. W. Fore, deceased, by deed recorded in deed vol. 903, page 266, and is conveyed subject to any recorded restrictions, easements or rights of way or those shown on the ground.
