

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgage to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being known and designated as Lot 25 of Cedar Vale Subdivision, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book 000, at Page 13, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the southern side of Verner Drive, at the joint front corner of Lots 25 and 26, and running thence S. 74-42 E., 100 feet to an iron pin at the joint front corner of Lots 24 and 25; thence with the common line of said Lots S. 15-18 W. 178.6 feet to an iron pin; thence N. 74-58 W.65.9 feet to a point; thence N. 74-52 W. 34.1 feet to an iron pin at the joint rear corner of Lots 25 and 26; thence with the common line of said Lots N. 15-18 E. 178.8 feet to the point of beginning.
