

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot.

No. 109 of a subdivision known as Hillsborough, Section Two, according to a plat thereof prepared by Jones Engineering Service and recorded in the R. M. C. Office for Greenville County in Plat Book 4 F, at Page 51, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Libby Lane at the joint front corner of Lots Nos. 108 and 109, and running thence with the joint line of said lots, S. 7-33 W. 168. 2 feet to an iron pin at the joint rear corner of Lots 108 and 109; thence with the rear line of Lot No. 109, S. 81-14 E. 118. 2 feet to an iron pin at the joint rear corner of Lots Nos. 109 and 110; and running thence with the joint line of said lots, N. 4-41 E. 171. 3 feet to an iron pin on the southern side of Libby Lane, joint front corner of Lots Nos. 109 and 110; thence with the southern side of Libby Lane, N. 83-53 W. 18. 3 feet to an iron pin; thence continuing with the southern side of Libby Lane, N. 82-27 W. 91. 7 feet to the point of beginning; being the same conveyed to the mortgagor corporation by deed of even date, to be recorded herewith.
