NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

LOCATED on the South east side of Gover Street, Fifth Mard. City of Greenville, and known and dead designated as lot No. 7 of the Ware land, Possibled as follows:

EDGINMIN at a stake on Gower Street, on corner of lot No.8 and running thereo with cald street S. 69-3/4 W. 65 feet to stake on corner of Cornelia Jennings let; thereo slong ben line S. 20-1/4 E. 120 feet to stake on line of lot No. 5; thense W. 60-3/4 E 65 feet with line of lot No. 5 to stake on corner of lot #8; thense along line of last montioned lot No. 20-1/4 W 120 feet to beginning.
