"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, ALL that lot of land being in the State of South Carolina, County of Greenville, Chick Springs Township, on the West side of Morrow Street, in or near the City of Greer, and being part of Lot 9 and a portion of Lot 8 as shown on a plat of the William S. Moore property, by H. S. Brockman, Surveyor, dated April 24th, 1944 and also being shown on a survey entitled property of James T. Smith, dated November 14, 1949 by H. S. Brockman, Surveyor, and having according to said plat the following metes and bounds, to-wit:
