WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty-days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgager to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Pinnacle Drive near the City of Greenville, being known and designated as Lot No. 56 of a subdivision known as Section C, Green Forest, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book KK at Page 87, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Pinnacle Drive, joint front corner of Lots Nos. 55 and 56, and running thence along the joint line of said lots, N. 80-35 E. approximately 193 feet to a point in the center of a branch; thence with the center of said branch as the line, following the meanders thereof, the traverse line of which is S. 9-25 E. 100 feet to a point, joint rear corner of Lots Nos. 56 and 57; thence with the joint line of said lots, S. 80-35 W. approximately 193 feet to an iron pin on the eastern side of Pinnacle Drive; thence with said drive, N. 9-25 W. 100 feet to the beginning corner; being the same conveyed to me by C. S. Mattox and Wilson M. Dillard by deed dated July 19, 1971, to be recorded herewith.

This mortgage is given in connection with a construction loan, and it secures a promissory note which provides, among other things, for monthly interest payments, the principal payable in full on or before 12 months from date.
