"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 6 on a revised plat of Meadowbrook Farms by C. O. Riddle, dated February 1958 and recorded in the RMC Office for Greenville County in Plat Book PP, page 113 and having, according to said plat, the following metes and bounds, to
