

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

JACK DALE

(hereinafter referred to as Mortgagor) (SEND(S) CREETINGS:
WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF
GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

TWENTY TWO THOUSAND and no/100------(\$ 22,000.00)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain
a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain
conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

One Hundred Sixty Six and 18/100----(\$ 166.18) Dollars each on the first day of each
month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment
of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner
paid, to be due and payable 25 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws of the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note/and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

. WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeastern side of Wood-ruff Road, Butler Township, containing 11 acres, more or less and being shown on a Plat entitled "Property of A. M. Bridges", dated June 30, 1971, prepared by Jones Engineering Service, and recorded in the RMC Office for Greenville County, South Carolina in Plat Book 4J, Page 61, and having according to said Plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northeastern side of Woodruff Road at the common corner with the property now or formerly of J. M. Bridges, thence N. 47-35 E., 158 feet to an iron pin; thence along the line of Woodruff Road Heights Subdivision, the following courses and distances: N. 28-14 E., 251.8 feet to an iron pin, N. 29-19 E., 441.5 feet to an iron pin; N. 20-27 E., 308 feet to an iron pin, N. 11-19 E., 230 feet to an iron pin, N. 9-31 W., 212 feet to an iron pin, N. $\overline{66-09}$ E., 97.5 feet to an iron pin and continuing N. 66-09 E., 15 feet, more or less, to the center of a branch; thence along said branch as the line, the traverse of which is S. 45-46 E., 170 feet and S. 74-17 E., 166 feet; thence leaving said branch and running S.43-13 W., 10 feet to an iron pin in the center of an old road bed; thence along the center of said road, the following courses and distances: S. 43-13 W., 130 feet to an iron pin, S. 24-25 W., 113.5 feet to an iron pin, S. 18-33 W., 128 feet to an imon pin, S. 10-56 W., 137 feet to an iron pin, S. 19-50 W., 277 feet to an iron pin, S. 3-07 W., 114 feet to an iron pin, S. 18-29 W., 123.5 feet and S. 5-34 W., 149.3 feet to an iron pin; thence N. 75-55 W., 27.6 feet to an iron pin; thence S. 30-21 W., 564.3 feet to an iron pin on the Northeastern side of Woodruff Road; thence along said road, N. 47-16 W., 221 feet to an iron pin; and N. 45-42 W., 156 feet to an iron pin, the beginning corner.
