TO ALL WHOM THESE PRESENTS MAY CONCERN:

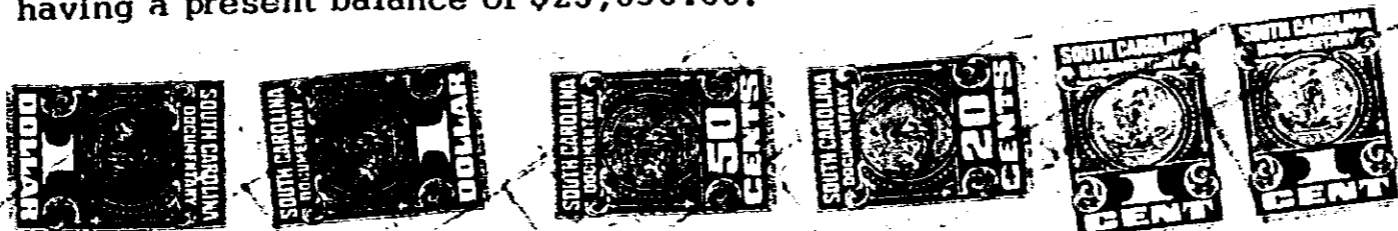

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being shown as Lot No. 133 on plat of Del Norte Estates recorded in the RMC Office for Greenville County, S.C., in Plat Book WWW, at Pages 32 and 33, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at a point on the edge of Coatbridge Road, joint front corner of Lots Nos. 132 and 133, and running thence with the common line of said lots, N. 41-01 E. 143.6 to a point; thence, N. 48-40 W. 105 feet to a point, joint rear corner of Lots Nos. 133 and 134; thence with the common line of said lots, S. 38-46 W. 136.04 feet to a point on the edge of Coatbridge Road; thence running with the edge of said road, S. 44-15 E. 100 feet to a point, the point of beginning.

This mortgage is junior in lien to that given to First Federal Savings and Loan Association covering the above described property as recorded in the RMC Office for Greenville County, S.C., in REM Book 1159, at Page 260, and having a present balance of \$23,390.36.
