NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as lot no. 83 Pine Hill Village as shown on plat prepared by R. K. Campbell, RLS, dated November 3, 1960, recorded in plat Book QQ at pages 168 and 169 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the southern side of Cashmere Drive at the joint Front corner of lots 83 and 84 and running thence with the line of lot 34 S. 10-44 W. 105 feet to an iron pin at the joint corner of lots 82, 83 and 84; thence with the line of lot 82, which is the center line of a 10 foot easement, N. 79-11 W. 85 feet to an iron pin on the eastern side of Daisy Drive; thence with Daisy Drive N. 10-49 E. 80 feet to an iron pin; thence with the curve of the intersection of Daisy Drive and Cashmere Drive, the chord being N. 55-44 E. 35.3 feet to an iron pin on the southern side of Cashmere Drive; thence with the southern side of Cashmere Drive S. 79-11 E. 60 feet to the point of beginning
