NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 28 on plat of Blueberry Park recorded in Plat Book BB at page 18, and having the following metes and bounds:

Beginning at an iron pin on the western side of Strawberry Drive at the joint corner of Lots 28 and 29; thence along the cormon line of said lots, N 86-55 W 158 feet to an iron pin; thence along the rear line of Lot #28, N 3-10 E 80 feet to an iron pin; thence along the common line of Lote 27 and 28, S 86-55 E 158 feet to an iron pin on the western side o Stawberry Drive; thence along said Drive, S 3-10 W (0 feet to the point of beginning.
