MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Mason A. Goldsmith and Harriet M. Goldsmith

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Eighteen Thousand Nine Hundred and no/100-----

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of East Greenville, on the southern side of East Faris Road, being shown as Lot 19 and portions of Lots 18 and 20 on plat of Block G, of Kanatenah Subdivision recorded in Plat Book F at page 131, and being further shown on a revision of Blocks G & N of said subdivision recorded in Plat Book H at page 288 in said RMC Office, and having according to the latter plat the following metes and bounds:

Beginning at an iron pin on the southern side of East Faris Road 11' from the joint corner of Lots 18 and 19, and running thence along East Faris Road, N 63-35 E 110 feet to a point in front line of Lot 20, said point being 33 feet from the corner of Lots 19 and 20; thence through line of Lot 20, S 26-30 E 160 feet to an iron pin in rear line of Lot 20; thence S 63-38 W 110 feet to an iron pin in rear line of Lot 18; thence with a new line through Lot 18, N 26-30 W 160 feet to the point of beginning.
