To All Whom These Presents May Concern: Colonial Company, Inc.

SEND GREETING:

Whereas, it, the said Colonial Company, Inc.

hereinafter called the mortgagor(s) in and by its certain promissory note in writing, of even date with these presents,
is well and truly indebted to Citizens Builders Mart, Inc.

hereinafter called the mortgagee(s), in the full and just sum of Four Thousand Five Hundred and No/100

six (6) months from date

, with interest thereon from date

at the rate of -----seven (7%)-----
at maturity percentum per annum, to be computed and paid
interest at the same rate as principal. until paid in full; all interest not paid when due to bear

And if any portion of principal or interest be at any time past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole amount evidenced by said note to become immediately due at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including ten (10%) per cent, of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

ALL that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the east side of Oak Park Drive and being known and designated as Lot 42 and a portion of Lot 41 on plat of Parkwood, Section 1, which plat was made by C. O. Riddle, Surveyor, July 27, 1969, and recorded in the R.M.C. Office for Greenville, S. C. in Plat Book 4-F, Page 22, and having, according to a more recent plat entitled "Revised Plat of Lots 40, 41 and 42, Parkwood, made by C. O. Riddle, Surveyor, August 10, 1971, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Oak Park Drive at the joint corner of Lots 42 and 43 and runs thence along the line of Lot 43 N. 81-49 E. 150 feet to an iron pin; thence S. 8-11 E. 75 feet to an iron pin; thence S. 12-28 E. 14.6 feet to an iron pin; thence along a new line through Lot 41 S. 81-41 W. 148.9 feet to an iron pin on the east side of Oak Park Drive; thence with the curve of Oak Park Drive (the chord being N. 12-01 W. 31.2 feet) to an iron pin; thence continuing with the curve of Oak Park Drive (the chord being N. 8-11 W. 58.8 feet) to the beginning corner.
