

And they do hereby bind their Heirs, Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said mortgagee, its successors and Assigns, from and against their Heirs, Executors, Administrators and Assigns and Executors, I follow claiming or to claim the same or any part thereof



And if at any time any part of said debt, or interest, and profits of the above described premises to the said mortgagee, or its successors or Assigns and agree that any cause.
