NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Riviera Drive, near the City of Greenville, being shown as Lot 254 on a plat of Section V of Botany Woods, recorded in Plat Book YY at Page 7, in the RMC Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Riviera Drive, at the corner of Lot 253, and running thence with the northeastern side of said Drive S 47-15 E 120 feet to an iron pin at the corner of Lot 255; thence with the line of said lot N 36-09 E 202.5 feet to an iron pin the line of Lot 250; thence with the line of said lot N 55-15 W 20 feet to an iron pin at the corner of Lot 25; thence with the line of Lots 251 and 252, N 96-05 W 86.6 feet to an iron pin at the corner of Lot 253; thence with the line of said lot S 46-25 W 144.3 feet to the beginning corner.
