ALL that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the County of Greenville, State of South Carolina, lying on the Northwestern side of Old Anderson Road (South Carolina State Highway 81) and being a portion of that certain tract shown and designated as Tract 4 on Plat of DIXIE FARMS, which said Plat is recorded in the RMC Office for Greenville County in Plat Book L, at Pages 3 and 5. Said parcel herein mortgaged contains one (1) acre more or less and has the following courses and distances:
