WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, approximately four miles north of the City of Greer, on Lake Cunningham lying on a county road, (now known as Lake Cunningham Road), shown as 85/100 of an acre on a plat of the property of A. E. Dean and Doris H. Dean, prepared by John A. Simmons, R.L.S., dated May 15, 1964, recorded in the R.M.C. Office for Greenville County in Plat Book GGG, Page 157, and having according to said plat the following courses and distances, to wit:

BEGINNING at a stake in the Lake Cunningham Road, the southeast corner of the lot herein (iron pin on bank of road at 19 feet from true corner), and running thence S.58-24 W. 134 feet to an iron pin on the water right line of the City of Greer; thence with that line, N.37-08 W. 186.5 feet to an iron pin and N.28-28 W. 77.2 feet to an iron pin; thence N.64-18 E. 150.8 feet to a stake in the said Lake Cunningham Road; thence along said road S.31-04 E. 247 feet, to the beginning corner.

This is the identical property conveyed to the mortgagors herein by deed from Arthur E. Dean and Doris H. Dean dated June 3, 1968, recorded in the R.M.C. Office for Greenville County in Deed Book 845, Page 585.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
