NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

C., AT THE INTERSECTION OF MILLER ROAD AND THE C. C. CAMP ROAD. AND HAVING THE FOLLOWING METES AND BOUNDS ACCORDING TO A SURVEY BY H. S. BROCKMAN, SURVEYOR, AUG 1945, AMENDED 4-6-57.

BEGINNING AT A NAIL IN THE CENTER OF THE MILLER ROAD AND RUNNING THENCE N. 10 W., 24 FEET; THENCE STILL WITH THE CENTER OF SAID ROAD N. 5-51 W., 436 FEET; THENCE STILL WITH THE CENTER OF ROAD N. 2-20 W., 100 FEET; THENCE STILL WITH SAID ROAD N. 2-30 E., 200 FEET TO A NAIL IN THE CENTER OF SAID MILLER ROAD (STAKE SET OFF ON WEST BANK 25 FEET FROM CENTER OF ROAD); THENCE S. 66-26 W., 391.5 FEET; THENCE S. 8-00 W., 276 FEET TO A POINT IN THE CENTER OF THE C. C. CAMP ROAD; THENCE WITH THE CENTER OF THE G. C. CAMP ROAD S. 55-15 E., 530 FEET TO THE BEINNING CORNER, AND CONTAINING 4.4 ACRES MORE OR LESS.

THIS IS A PART OF THE SAME PROPERTY CONVEYED TO THE WITHIN GRANTOR BY J. A. BURNETT BY DEED RECORDED IN DEED BOOK 280 PAGE 386, GREENVILLE COUNTY R. M. C. OFFICE.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as herein specifically stated otherwise as follows: THIS IS A SECOND MORTGAGE SUBJECT TO THE

FIRST MORTGAGE GIVEN TO CITIZENS BUILDINGS & LOAM

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortagagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.

(2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgagee debt, whether due or not.
