"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing approximately 10 acres, and being more particularly described by metes and bounds,

BEGINNING at a point at the northwest corner of the 5.2 acre tract conveyed by deed recorded in Book of Deeds 720, at Page 155, in the center of Grand Drive-Way (now Pinsley Circle), and running thence N 89-13 E 423.5 feet to an iron pin; thence N 89-30 E 532.5 feet to an iron pin; thence S 1-02 E 264.5 feet to an iron pin; thence N 88-32 E 165 feet to an iron pin; thence S 1-02 E 265 feet to an iron pin; thence S 89-00 W 165 feet to an iron pin; thence S 89-30 W 634 feet to an iron pin; thence S 89-20 W 318 feet to an iron pin; thence N 0-59 W 524.7 feet to the point of beginning in Pinsley Circle, with all exits and entrances appurtenant thereto.

It is expressly understood and agreed that this mortgage does not include the existing railroad track, the 50-foot railroad scales, the scales house and the fixtures and equipment related thereto, all of which are now located on the subject property.
