"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oaklawn Township, lying on the South side of Old Pelzer Road at its intersection with Williams Road, and having, according to a plat by Carolina Engineering and Surveying Company, recorded November 19, 1970 in Deed Book 903, at Page 228, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Old Pelzer Road at its intersection with Williams Road and running thence S. 73-15 E. 250 ft.; thence S. 48-37 W. 263.3 ft. to an iron pin; thence N. 46-33 W. 200 ft. to an iron pin in Williams Road, an iron pin being on the East side of said road approximately 15 feet from the pin in the road; thence with the East side of Williams Road, N. 43-27 E. 150 feet to an iron pin; the point of beginning; being a portion of that tract of land conveyed to Hattie H.
