TO ALL WHOM THESE PRESENTS MAY CONCERN:

Herbert E. Rudd and Hery W. Goldsberry

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Eleven Thousand Five Hundred and no/100-------DOLLARS

(\$11,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 15 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, containing four acres, and having the following metes and bounds according to plat by Dalton and Neves, Engineers, dated April, 1935, to-wit:

BEGINNING at a stake on Mountain Creek Road at the corner of the lands of L. Walters and Minnie Littleton, running thence N. 4-15 E. 597.6 feet to a stake, corner of lands of Will F. Roberts, Minnie Littleton and Carolyn E. DeChant; thence along line of DeChant land N. 83-25 W. 133.5 feet to an iron pin; thence S. 40 W. 391.2 feet to a stake; thence S. 20-45 E. 441.7 feet to a stake on Mountain Creek Road; thence N. 61-20 E. 210 feet along said Road to a stake and beginning corner, being bounded on the east by lands of L.
