TO ALL WHOM THESE PRESENTS MAY CONCERN:

Minnie Lee Harper ----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Eleven Thousand Five Hundred and No/100 -----DOLLARS

(\$11,500.00 -----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is -----10----- years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville on Allen Street and known and designated as Lot No. 5, Section 4 of a subdivision of property of Dunbar Mill, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book S at Page 173 through Page 177, inclusive; said lot having such metes and bounds as shown thereon and also known as #83 Allen Street.

Also: ALL that piece, parcel or lot of land situate, lying and being on McGarity Street, the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 3, Block J of a subdivision known as Melrose Land Co., plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book A at Page 157; said lot fronts on said street 50 feet and has a depth and parallel lines of 140 feet.

Also: ALL that piece, parcel or lot of land situate, lying and being on Woodside Avenue in the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 11 and 10 feet of Lot No. 12, adjoining of a subdivision known as Donwood, plat of which is recorded in Plat Book A at Page 463 in the R.M.C. Office for Greenville County and has such metes and bounds as shown thereon.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
