All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the East side of Pine Street Extension, in the City of Greer, and being known and designated as lots nos. Two (2) and Three (3) of the J. 0. Burnett property as shown on plat prepared by H. S. Brockman, Surveyor, dated June 11, 1941 and which plat has been recorded in the R. M. C.
