"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, situate on the western side of Dexter Drive, being shown and designated as Lot 69 on plat of Drexel Terrace recorded in Plat Book QQ at Page 177 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Dexter Drive at the joint front corner of lots 69 and 70 and running thence with the line of lot 70 N. 82-07 W. 167.5 feet to pin; thence S. 6-23 W. 100 feet to pin at rear corner of lot 68; thence with line of lot 68 S. 82-07 E. 165 feet to pin on Dexter Drive; thence with the western side of Dexter Drive N. 7-53 E. 100 feet to thepoint of beginning.
