BEGINNING at a stone at the northwest corner of the tract and going thence S. 6 E. 2.4 chains; thence with the branch as the line along what was W. S. Turner's land to an iron pin; thence S. 29½ W. 10.44 chains; thence S. 9¼ W. 5.58 chains; thence along Beaver Dam Creek, =to the mouth of the branch; thence N. W. 3.65 chains; thence N. 35½ E. 3.24 chains; thence N. 26½ E. to the southeast corner of lot conveyed to A. B. Hart; thence with the A. B. Hart lot, 100 feet to the corner of the lot; thence N. E. 150 feet to the road; thence with the road to the point of beginning.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
