"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the North side of Hubert Street and having the following metes and bounds, to-wit:
BEGINNING at an iron pin on Hubert Street, T.H. Nobles corner and running thence with the said Nobles lot N. 180 feet to the O.P. Smith line; thence E. 55 feet to Etake; thence S. 180 feet to a stake on Hubert Street, thence with said Hubert Street 55 feettto the beginning corner. This property is located in the City of Greer.

This is the same property conveyed to me by deed from H.E. Chaffin dated the 7th day of June, 1955, and recorded in the R.M.C. Office for Greenville County in Book 527 at page 104.
