"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville on the Northeastern side of Laurens Road, being shown and designated as a greater portion of Lot No. 14 on a Plat of the Property of Emma C. Poag, Block A, made by Dalton & Neves, Engineers, dated June 1939, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book K, Page 68, and being shown in part according to a more recent survey made by Jones Engineering Services, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4L, Page 181, the following metes and bounds, to-wit:
