MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Whereas: Jake Sullivan, James Boyd, Malcolm Gary, George Gary, George Sullivan, Elford Harris, Jr., J. Van Boyd, and Alvin Sullivan, as Trustees-Deacons of Cedar Grove Baptist Church, (hereinafter referred to as Mortgagor) is well and truly indebted unto The Peoples National Bank, Simpsonville, South Carolina,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two Thousand Eight Hundred Fifty and No/100----- Dollars (\$ 2,850.00 ) due and payable

at the rate of \$200.00 per month, first applied to interest, balance to principal,

with interest thereon from date at the rate of eight (8) per centum per annum to be paid: monthly.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Simpsonville, containing two acres, more or less, and being the same property conveyed to the Deacons of Cedar Grove Baptist Church by two deeds, one recorded in the R.M.C. Office for Greenville County in Deed Volume 08 at Page 590 and Deed Volume 'YY' at Page 806. This being all the same property conveyed in these two deeds, less a 30-foot by 40-foot lot conveyed to the Hopewell Lodge No. 263 F and AM in Deed Volume 93 at Page 234.

This mortgage is second and junior in lien to that certain first mortgage given by the mortgagor herein unto The Peoples National Bank, said mortgage having been recorded in the R.M.C. Office for Greenville County in Mortgage Volume 1173 at Page 267.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
