If the Mortgages fails to make any physicants provided for in this section or any other payments for taxes, assessments, or the like, the Mortgages may pay the same, and all sums so paid shall bear interest at the rate provided for in the principal indebtedness from the date of such advance and shall be secured by this mortgage.
- 6. Upon the request of the Mortgages the Mortgages shall execute and deliver a supplemental note or notes for the sum or sums advanced by the Mortgages for the alteration, modernization, improvement, maintenance or repair of said premises, for taxes or assessments against the same and for any other purpose authorized hereunder. Said note or notes shall be secured hereby on a parity with and as fully as if the advance evidenced thereby were included in the note first described above.
