PARTIAL RELEASE OF LIEN

(Bank Loan No **S 184-727**)

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of one dollar and other considerations, receipt whereof is hereby acknowledged, The Federal Land Bank of Columbia, the owner and holder of the security instrument hereinafter referred to and of the note thereby secured does, subject to the conditions hereinafter stated, hereby release from the lien of that certain security instrument from **H. W. Johnson and Lallie G. Johnson**

to The Federal Land Bank of Columbia, securing the payment of the principal sum of **Two Thousand Eight Hundred**

(\$ **2,800.00**) Dollars, dated the **10** day of **August**, 19 **67**,

and recorded in the public records of **Greenville** County, State of **S. C.**

in **Mortgage** Book **1066**, at page **455**, the following described property, to-wit:

All that piece, parcel or tract of land in Austin Township, County of Greenville, South Carolina, in School District 559, Section 02, tract 3, and containing Two (2) acres, more or less, being bounded on the North by **H. W. Johnson's** land, on the East by **Johnson Road**, on the South by **O. C. King** land, and on the West by **H. W. Johnson** land, and being more particularly described on plat by **John E. Woods**, RLS No. 3980, and dated November 22, 1971.

PROVIDED, HOWEVER, that the security of The Federal Land Bank of Columbia as described in the aforesaid security instrument shall, in all respects, except as to the premises hereinbefore described, be preserved and protected and that the lien of said security instrument, except as hereby released and discharged, shall remain in full force and effect and the terms, conditions and covenants thereof and of the note thereby secured, shall remain unchanged
