TO ALL WHOM THESE PRESENTS MAY CONCERN:

WILLIAM E. LIVERMAN (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fifty-three Thousand -----  
DOLLARS (\$ 53,000.00 ), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Western side of Franjo Street near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 105, 106, 107 and 108 as shown on a plat of the Cuttino Heirs Property recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book J at page 121, and having in the aggregate, according to said plat the following metes and bounds:

BEGINNING at an iron pin on the western side of Franjo Street at the joint front corner of Lots Nos. 108 and 109, and running thence with the line of Lot No. 109 S. 89-15 W 114 feet to an iron pin; thence with the rear lines of Lots Nos. 100, 101, 102, 103 and 104 in a Southerly direction 122.3 feet to an iron pin; thence N. 78-31 E. 120.8 feet to an iron pin on the western side of Franjo Street; thence with the Western side of Franjo Street N. 1-57 W. 100 feet to the point of beginning.

This is the identical property conveyed to the mortgagor herein by deed of Joseph W. Walker, dated May 11, 1957, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 576 at page 463.

Franjo Street referred to hereinabove is now known as Cuttino Circle.

ALSO: All that piece, parcel or lot of land, with all improvements thereon, situate, lying and being on the Western side of Bahan Road (also known as Bahan Street) in the County of Greenville, State of South Carolina, being known as a portion of Lot No. 9 of a plat entitled "Plat No. 2 - Property of W. S. Bradley by Dalton & Neves dated April, 1945, and recorded in the R. M. C. Office for Greenville County in Plat Book O at page 169 and being further shown as two lots, designated respectively as property of "Hall & Cox" and property of
