All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Mauldin, on the north-western side of Pinehurst Drive, being known and designated as Lot No. 9 on plat of Section 1, Pine Valley Estates as shown on a plat thereof prepared by Dalton & Neves, Engineers dated February 1960 and recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 138, and having, according to said plat, the following metes and bounds, to-wit:
