"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Saluda Township, about 21 miles north of Greenville County Court House and being shown as Tract #2 of a plat prepared by H. T. Corn, Surveyor, dated September 27, 1951, and recorded in Plat Book T, at page 365 and having the following metes and bounds, to-wit:

BEGINNING at a point in Terry Creek Road at the joint corner of Tract #1 and Tract #2 and running N. 33-30 W. 475 feet, more or less, along said Road to a point at the joint corner of Tract #2 and Tract #3; thence running N. 56 E. 387 feet to a point at the joint corner of Tract #'s 2, 3 and 8; thence S. 21 E. 60 feet to a point; thence S. 74-45 E. 400 feet to Panther Creek; thence along said Creek S. 61 E. 64 feet to a point; thence S. 14 W. 137 feet to a point the joint corner of Tract #1 and Tract #2; thence S. 59 W. 640 feet to the point of beginning.
