WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgages for such further sums as may be advanced to er for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bergain, sell and release unfo the Mortgagoe, its successors and essigns:

"ALL that certain piece, parcel or lot of land, with all imprevements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carelina, County of Greenville, Grove Township, lying and situated

in Grove Station School District, State and County aforesaid, and containing one-half (1/2) acre, more or less, and having the following metes and bounds, to - wit:

BEGINNING at an iron pin, joining corner Mrs. Elizabeth Young and Grantee thence along Mrs. Elizabeth Young line N 20-30 W 180 feet to iron pin, joint corner of Grantor, Mrs. E. A. Cason and Grantee, thence along Mrs. A. E. Cason line N. 70E. 122 feet 6 inches to iron pin in road; thence along said road S 20-30 E 180 feet to iron pin, intersection of roads, thence down Moody Road S 70-0 W 122 feet 6 inches to beginning corner, this being the northeast portion of the identical land conveyed to Grantor by deed of Ralph M. TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor coverants that it is lawfully seized of the premises hereinabove described in fec simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever tawfully claiming the same or any part thereof.
