Fifty and No/100----- Dollars (\$ 19,950.00), with interest from date at the rate of
seven per centum (7 %) per annum until paid, said principal and interest being payable
at the office of C. Douglas Wilson & Co.
in Greenville, South Carolina, or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of One Hundred Forty-
One and 05/100----- Dollars (\$ 141.05), commencing on the first day of
April, 1972, and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
payable on the first day of March, 1997.

payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described
property situated in the county of Greenville

All that piece, parcel or lot of land situate, lying and being in the
County of Greenville, State of South Carolina, near the City of Greenville,
located on the Western side of Knox Street, and on the Southern side of
Dresden Avenue, being shown as Lot No. 86 and the Northern one-half of
Lot No. 87 on a plat of Glendale Heights of record in the Office of the
RMC for Greenville County in Plat Book KK, Page 143, and being more specifically
shown on a plat entitled "Property of John Thomas Curenton" prepared by
Carolina Surveying Company February 24, 1972, of record in the Office of
the RMC for Greenville County in Plat Book 4M, Page 133, reference to said
latter plat being craved for a metes and bounds description thereof.
