

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Evergreen Circle, and being known and designated as Lots Nos. 5, 6, and a portion of Lot No. 7, on Plat of Lakewood, recorded in the R. M. C. Office for Greenville County, in Plat Book BBB, at Page 181, and having, according to a more recent survey thereof prepared by Webb Surveying and Mapping Company, dated February, 1972, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Evergreen Circle at the joint

front corner of Lots 4 and 5, and running thence along the joint line of said Lots N. 45-46 E. 153.5 feet to an iron pin; thence N. 43-09W. 287.8 feet to an iron pin; thence S. 31-46 W. 251.2 feet to an iron pin in the rear line of Lot 7; thence through Lot 7 S. 51-47 E. 176.6 feet to an iron pin on Evergreen Circle; thence along said Circle as follows: N. 8-42 E. 47.6 feet to an iron pin in the joint front corner of Lots 6 and 7; thence with the curve of said Circle N. 43-24 E. 60 feet to an iron pin in the joint front corner of Lots 5 and 6; thence continuing with the curve of said Circle S. 58-40 E. 60 feet to the point of beginning.
