"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the West side of Brockman Avenue, being part of Lots 20, 27 and 28 of the subdivision known as Sans Souci Villa, as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book A at Pages 510 and 511 and having the following metes and bounds, to-wit:
