"ALL that certain piece, percel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville in the City of Greenville, lying and being on the Southern side of Pendleton Street and being known and designated as LOT No. 3 (less a 5-foot strip in width along the western edge of said lot) on a plat of the property of Henry T. Mills recorded in the RMC Office for Greenville County, S. C. in Plat Book A, page 459 and having, according to said plat, the following metes and bounds:
