All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeasterly side of Castlewood Drive, near the City of Greenville, S. C., being known and designated as Lot No. 24, on Plat entitled "Final Plat Revised, Map No. 2, Foxcroft, Section II" as recorded in the R. M. C. Office for Greenville County, S.
