All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the northern corner of the intersection of Bancroft Street and Driftwood Drive, and being known and designated as Lot No. 28, as shown on a Plat of Property of William R. Timmons, Jr., made by C. O. Riddle, Surveyor, July, 1967, and recorded in the R. M. C. Office for Greenville County, in Plat Book "000", at Page 193, and having, according to said Plat, the following metes and bounds, to-wit:
