ALL that certain parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Highland Township, containing 32.5 acres, more or less, according to Plat of the T. M. Stokes estate made by W. N. Willis, Engineer, dated April 11, 1972, and recorded in the R. M. C. Office for Greenville County in Plat Book _____, page _____, and having the following metes and bounds:
