"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Stratford Road, being known and designated as Lot No. 91 on a plat entitled "South Forest Estates", dated August 29, 1955, by Pickell & Pickell, Engineers, said plat being recorded in Greenville County Plat Book GG, at page 181, and having according to said plat the following metes and bounds, to-wit:
