"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the East side of Wood Road about 12 miles SW of Fairview School, near Lick Creek, containing one acre, more or less, and bounded by lands of N. W. Wood, and having the following metes and bounds, to-wit:
