BEGINNING at a point in the center of Haywood Road and running thence S. 55-38 E. 37.5 feet to an iron pin on the southeasterly side of Haywood Road; thence continuing the same course, 196.9 feet to an iron pin in line of property of Smith; thence turning and running S. 26-45 E. 235.9 feet to an iron pin on the northerly side of Woods Crossing Road; thence continuing the same course, 4.8 feet to a point within the right-of-way of said Woods Crossing Road; thence turning and running S. 63-03 W. 66.8 feet to an iron pin; thence S. 63-12 W. 44.70 feet to a point; thence continuing S. 63-12 W. 150.0 feet to a point; thence turning and running N. 26-48 W. 30.0 feet to a point; thence turning and running N. 63-12 E. 95.0 feet to a point; thence turning and running N. 26-48 W. 69.70 feet to a point; thence turning and running N. 55-41 W. 235.74 feet to a point on the southeasterly side of Haywood Road; thence continuing the same course, 37.5 feet to the center of Haywood Road; thence turning and running along the center of Haywood Road, N. 34-19 E. 212.0 feet to the point of beginning (subject to the right-of-way of Haywood Road).
